Northeast Arkansas will once again have a full century bike ride. Formerly the *Ride for a Better Life*, this event will also offer a 10-mile family fun ride. The ride will begin and end at the offices of Better Life Counseling Center, located on the campus of Southwest Church of Christ, behind the YMCA off Nettleton Avenue. Registration will begin at 6:45 am with all riders starting at 8:00 am, in conjunction with riders completing 25, 62 and 100-mile distances!

Along with a rest stop, riders will enjoy sag support and medical attention provided by Medic One. A family of four, including riders age 5-12, can register in advance for \$40 or the day of the event for \$50. **This fee includes a pasta dinner on Friday night provided by Olive Garden and Fazoli's, as well as lunch after the ride by BA Burrito.**

Harvest Hundred T-shirts are guaranteed to those that register before September 21, 2010. All riders under 14 must be accompanied by an adult at all times on the course.
